WHEREAS applications have been received to purchase the lands described in the Schedule hereto for use as sites for summer residences;

AND WHEREAS portions of the said lands lie within one hundred feet of the ordinary high water mark of Braeburn, Laberge, Little Fox and Teslin Lakes, in the Yukon Territory;

AND WHEREAS the said lands are not required for public purposes.

THEREFORE, HIS EXCELLENCY THE GOVERNOR GENERAL IN COUNCIL, on the recommendation of the Minister of Indian Affairs and Northern Development, pursuant to section 8 of the Territorial Lands Act, is pleased hereby to order that all those portions of the lands described in the Schedule hereto lying within one hundred feet of the ordinary high water mark of Braeburn, Laberge, Little Fox and Teslin Lakes be included in the grants of the said lands.
