ORDER WAIVING THE RESERVATION TO THE CROWN WITH RESPECT TO CERTAIN TERRITORIAL LANDS IN THE YUKON TERRITORY

## Short Title

1. This Order may be cited as the Reservation to the Crown Waiver Order, 1985, No. 1.

## Waiver

2. The reservation to the Crown set out in paragraph 9(b) of the Territorial Lands Act is hereby waived with respect to a grant of the territorial lands described in the schedule.

## SCHEDULE (S.2)
