Dear Lisa Guo:

Re: Class 1 Notification P2022\_0365 - Allowed with additional terms and conditions.

This letter is to inform you that your Class 1 Notification P2022\_0365 is valid as of November 15, 2022.

Your Class 1 Notification and proposed work program (November 15, 2022 - November 15, 2023) is allowed to proceed with the following terms and conditions:

1. The operator shall conclude activities in caribou fall breeding wildlife key areas as identified on GeoYukon by September 15th each year.
2. The operator shall cease work when any moose or caribou are observed on active claim blocks until moose or caribou move off on their own accord.
3. The operator shall install and maintain safety fencing around all trenches deeper than two meters and install covers over the openings of all trenches with a material capable of preventing people or wildlife from inadvertently falling into the trenches.
4. The operator shall backfill each trench once a geological evaluation of the trench has been completed or prior to the end of the work program date identified in this Class 1, whichever occurs first.
5. The operator shall ensure trenches are sloped on at least one end at a grade

- shallow enough to allow ungulates to exit the trench.
6. The map provided identifies areas with elevated potential for heritage resources. The operator shall avoid ground disturbing activities within these areas unless prior approval has been granted by the Heritage Resources Unit. The operator may contact Holly Smith at the Heritage Resources Unit (867-332-4057 or holly.smith@yukon.ca) for more information on the areas of heritage potential to discuss potential mitigation options prior to conducting any ground disturbing activities.
  7. Drill holes shall be decommissioned and backfilled or plugged to avoid wildlife entrapment.
  8. You are reminded that you must comply with the Schedule 1 Operating Conditions, especially #33, which states: "All reasonable care must be taken in carrying out an operation near or adjacent to a water body to prevent sediment from entering a water body, unless otherwise permitted by law." You are also reminded that a leave strip is required for all placer streams for the protection of riparian areas, and its dimensions are dependent on the stream's habitat suitability classification as defined in the Fish Habitat Management System for Yukon's Placer Mining.
  9. Equipment (i.e. heavy equipment, hand-held tools, drills) shall be cleaned of foreign soil and plant material prior to moving it onto the project property.
  10. Off road use in the summer should be kept to a minimum, as much as possible.
  11. The operator shall take all necessary precautions to minimize disturbance to caribou specific habitat (lichen) within the project area.
  12. The operator should familiarize themselves with the rare plant species Klaza Draba. Disturbance of this plant should be avoided.

Security may be required at any time by the Chief. The operator must furnish security within thirty (30) days of receiving the written notice from the Chief of the requirement to post security.

To help improve the environmental performance of your program, you are encouraged to refer to the attached operational guidelines. In addition, you are encouraged to contact affected First Nations to further discuss your program.

Class 1 work cannot occur on claims/leases that have lapsed or pending claims/leases until they are granted by a Mining Recorder. Please ensure the claims/leases within your Class 1 Notification are in good standing prior to beginning your work program. Any work occurring on pending or lapsed claims/leases will be in contravention of the *Placer Mining Act* and *Territorial Lands (Yukon) Act* and representation work conducted will not be accepted by the Mining Recorder.

Please note: the notification will expire on November 15, 2023 and all reclamation must be completed at the end of the program or prior to the expiry of this notification, whichever comes first. All proposed activities must abide by Schedule 1 (Operating Conditions) of the *Placer Mining Land Use Regulation*. In the event that claims/leases lapse, a Class 3 or 4 authorization is issued, or that agreements to operate on claims/leases are dissolved, the Class 1 notification becomes null and void for that portion of the program, where there is

no right to the minerals.
