**Re: Approval of the Reclamation and Closure Plan**

Pursuant to section 10.1 of Quartz Mining License QML-0007 (the "License"), the Preliminary Reclamation and Closure Plan entitled "Preliminary Detailed Closure and Reclamation Plan", dated December 2008, and prepared by Access Consulting Group was approved, subject to any terms and conditions specified by the Chief and provided in writing to the Licensee within 30 days of the effective date of the License.

Upon further review, I have determined that the approval is subject to the following terms and conditions:

1. The approved Preliminary Reclamation and Closure Plan is replaced by a revised version entitled "Carmacks Copper Project, Yukon Territory, Preliminary Detailed Closure and Reclamation Plan", dated May 2009, and prepared by Access Consulting Group.
2. Should there be any inconsistency between the Preliminary Reclamation and Closure Plan and terms and conditions of the License, the License terms and conditions will prevail.
3. The approval of the Preliminary Reclamation and Closure Plan is given only for the portions that describe the reclamation and closure aspects of the Undertaking.

Schedule C of the License has been updated to reflect the revised version of the Preliminary Reclamation and Closure Plan. An updated Schedule C is attached to this letter and replaces any previous version.
