## RE: Quartz Mining License QML-0011 Quarterly Wildlife Report

The Quartz Mining License QML-0011 issued to Victoria Gold (Yukon) Corp. (VGC) requires the Licensee to provide quarterly monitoring reports of wildlife observations and incidents to the Director and the Inspector on the first working day in March, June, September and December of each year (Clause 13.8). The information contained herein with respect to wildlife reporting represents the quarterly monitoring report and includes all observations collected in March, April, and May of 2020 from the Eagle Gold Mine site (Table 1).

Site activities were ongoing through the reporting period with regular wildlife observations. During the period on the report, there was one wildlife interaction involving a Black Bear and 2 cubs. On May 27, 2020, a Sow and 2 cubs were observed in close proximity to site facilities. Inappropriate waste sorting was determined to have potentially contributed to the bears interacting with site. The bears were deterred from site and the inappropriate waste sorting rectified upon discovery. Bear safety was the mandatory safety topic of the month of May and bear awareness and waste sorting education is ongoing at morning department toolbox meetings.

During this reporting period, site related traffic frequency on the Haggart Creek Road was reduced due to the VGC COVID-19 pandemic travel restrictions and the resultant reduction in visitors, contractors and non-essential site staff to the mine site.

Wildlife mitigation measures were implemented through mandatory Project site orientation, traffic control policies, nesting songbird surveys prior to vegetation disturbance, staff toolbox meetings and implementation of the Project's management plans including the wildlife observation reporting program. Ongoing education is provided to site workers during toolbox meetings and through informational bulletins related to observing and documenting wildlife, and managing site waste according to permits and best practices.

The annual late-winter moose aerial survey was conducted March 4 - 6, 2020, in accordance with VGC Project commitments, to monitor Project effects on moose distribution. The survey area included a 10 km radius around the Project site and the Haggart Creek and South McQuesten roads. The survey was completed by VGC employees, Environmental Dynamics Inc, and a First Nation of Na-Cho Nyak Dun (FNNND) representative. The final report is pending and will be submitted according to conditions of the Wildlife Research Permit #0319 issued by the Yukon Government Environment Branch.
