## RE: Quartz Mining License QML-0011 Quarterly Wildlife Report

The Quartz Mining License QML-0011 issued to Victoria Gold (Yukon) Corp. (VGC) requires the Licensee to provide quarterly monitoring reports of wildlife observations and incidents to the Director and the Inspector on the first working day in March, June, September and December of each year (Clause 13.8). The information contained herein with respect to wildlife reporting represents the quarterly monitoring report and includes observations collected in December 2021 and January and February 2022, from the Eagle Gold Mine site.

Site activities were ongoing through the reporting period with regular wildlife observations. During the period of the report, there were no wildlife incidents documented on site.

Wildlife mitigation measures continue to be implemented through mandatory Project site orientation, traffic control policies, pre-clearing wildlife surveys prior to vegetation disturbance, staff toolbox meetings and implementation of the Project's management plans including the wildlife observation reporting program. Ongoing education is provided to site workers during toolbox meetings and through informational bulletins related to observing and documenting wildlife, and managing site waste according to permits and best practices.
