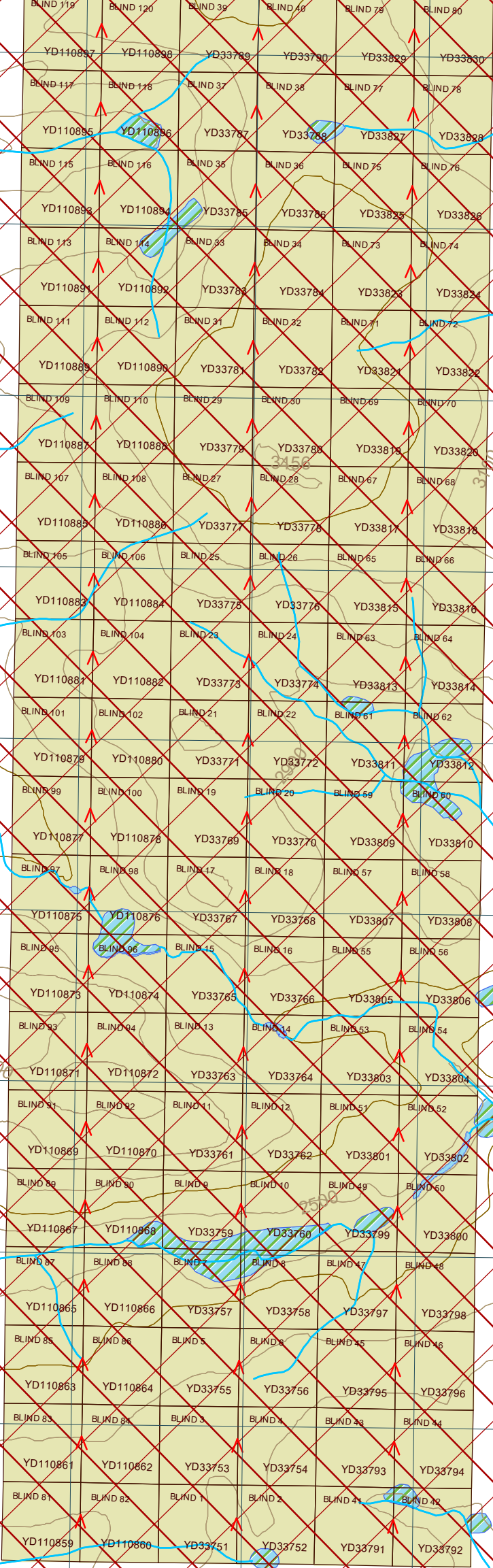


Kaska asserted traditional territory outside the Ross River Area
